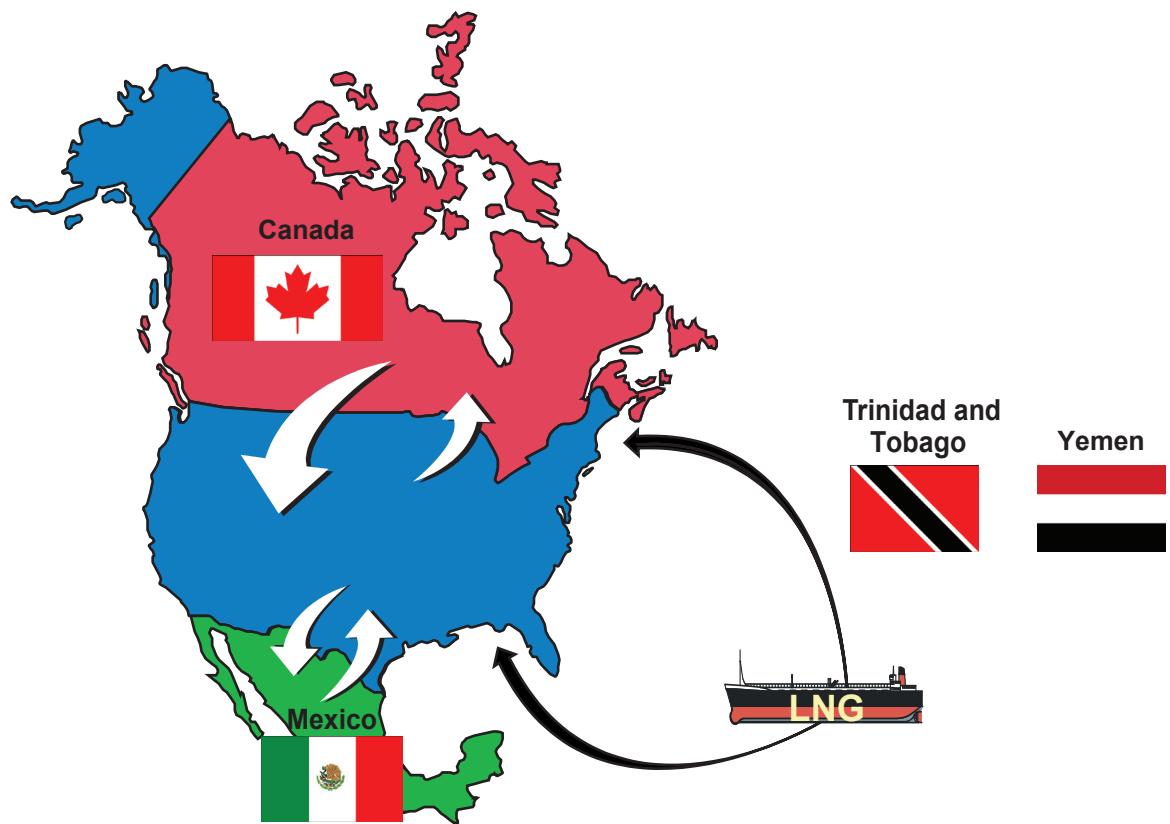

SUMMARY

The Office of Oil and Gas Global Security and Supply, Division of Natural Gas Regulatory Activities prepares quarterly reports on natural gas import and export activities. Companies are required, as a condition of their authorizations, to file monthly reports. This Natural Gas Import and Export Report is for the first quarter of 2014 (January through March).

Sections 1 and 2 contain quarterly summary charts and tables. Section 3 contains the detailed transactions of all imports and exports. The data in Section 3 is organized by activity: long-term imports, long-term exports, short-term imports, and short-term exports. Section 4 lists revisions made to data published previously. There is a table of contents for your convenience.

Please note that beginning with the fourth quarter of 2013, there were a few additional changes made to the tables in section 1 and some tables were re-numbered as a result – the previous table that covered trucked LNG imports was expanded into two tables (Table 1i and Table 1j); data previously covered in four tables is now covered in two, through the combination of pipeline import data for Mexico and Canada (Table 1e and Table 1f); and data on pipeline exports was broken out to show short-term and long-term totals (Table 1g and Table 1h).

First Quarter 2014 Highlights

Imports totaled 794.9 Bcf and exports totaled 423.1 Bcf, resulting in net imports of 371.8 Bcf. As usual, most of the imports came from Canada, comprising 98.1 percent of the total. LNG imports made up nearly all the remainder, 1.9 percent of total imports. Imports from Mexico totaled to 0.4 Bcf for the quarter. As with imports, the majority of exports went to Canada, making up 61.4 percent of the total. Exports to Mexico comprised the remainder. There were no domestic LNG exports by vessel, but there was an LNG re-export of 2.7 Bcf.

LNG exports by truck to Canada and Mexico continued in the first quarter, totaling 0.2 Bcf.

First Quarter 2014 vs. Fourth Quarter 2013 - Highlights

As illustrated in the following tables, total imports increased by 7.9 percent compared to last quarter. This increase in imports was due to a 39.2 percent increase in LNG imports by vessel and a 7.5 percent increase in pipeline imports. The average price of imports nearly doubled with a 96.2 percent increase. The average price of Canadian pipeline imports rose by 97.6 percent. This extreme price increase is attributed to the severe winter weather in the U.S. Northeast and Midwest.

Total exports were up 19.7 percent from last quarter. This growth was due, in large part, to an increase in Canadian pipeline exports. There was also an increase in Canadian exports by truck of 66.6 percent. There were no domestically produced LNG exports by vessel, while LNG re-exports were down only slightly. Canadian pipeline export prices greatly increased as well, by 123.4 percent compared to last quarter, and total trucked exports prices (for LNG and CNG) were up 66.6 percent.

First Quarter 2014 vs. First Quarter 2013 – Highlights

Total imports were up 1.4 percent from the first quarter of 2013. There was a relatively large rise in Mexican imports, which increased by 599.4 percent (though only 0.3 Bcf in absolute terms). Imports from Canada were up 3.9 percent and imports of LNG by vessel were down by 54.7 percent. The average pipeline import price increased by 102.3 percent while LNG import prices increased by 40.4 percent.

Total exports decreased moderately from the first quarter of 2013, by 3.0 percent. Pipeline exports to Canada decreased by 6.3 percent, Mexican pipeline exports increased by 1.0 percent and Mexican trucked exports increased by 19.8 percent as compared to the first quarter of 2013. Trucked exports to Canada increased substantially, by 957.2 percent, though less than 0.1 Bcf in total. There were no domestically produced LNG exports in either quarter. There was a rise in pipeline export and trucked export prices by 99.1 percent and 69.4 percent, respectively, compared to the first quarter of 2013.

Imports and Exports of LNG by Vessel

Imports of LNG by vessel increased 39.2 percent compared to last quarter and decreased by 54.7 percent compared to the first quarter of 2013. Nine cargos of LNG were imported by vessel this quarter, compared to four cargos last quarter and 13 cargos in the first quarter of 2013. Prices of LNG imported by vessel were up 38.0 percent from last quarter and up by 40.4 percent from the first quarter of 2013.






Natural Gas Imports & Exports by Border Point






Natural Gas Imports, 1st Quarter 2014

- In the first quarter of 2014, the U.S. imported nearly 795 Bcf of natural gas.
- A large majority of imports originated from Canada, continuing a long-term trend. Trinidad & Tobago was the next-largest supplier, providing 1.6% of imports.
- The remaining volume was supplied by 2 other countries - Yemen and Mexico.



Avg. Import Prices, 1Q 2014



- Import prices averaged in the range of \$3.92 (for a very small amount from Mexico) to \$8.37 (for LNG from Trinidad and Tobago) per MMBtu during the quarter.
- A very cold winter, caused by southward movement of the polar vortex from the Arctic, increased demand for natural gas and increased import prices. Significant volumes imported at very high prices to the Northeast and the Midwest, Michigan in particular, drove the overall average up. Import prices in the West were markedly lower.

Domestic Natural Gas Exports, 1Q 2014


Total Domestic Natural Gas Exports - 420.4 Bcf


- More than 60% of U.S. exports of domestically-produced natural gas during the first quarter were sent to Canada. The balance was exported to Mexico.
- Prices of exports to Canada were higher than prices of exports to Mexico, with the average price of exports to Canada at \$9.23 per MMBtu and the average price to Mexico at \$5.35 per MMBtu. Higher prices in the north reflect (in part) a significant cold-weather pattern that occurred early in 2014.

Comparison of 1Q 2014 Imports with Previous Quarters




- The total volume of first quarter imports was higher than the previous quarter and the first quarter of last year.
- Imports from Canada were higher in the first quarter than both other quarters, while imports from Mexico remained at a very low level. LNG imports were higher than the previous quarter, but less than half the volume they accounted for in the first quarter of 2013.

Comparison of 1Q 2014 Exports with Previous Quarters




- The first quarter 2014 export volume was higher than last quarter, but slightly lower than the first quarter of last year.

Pipeline Imports from Canada by Entry Point




- Volumes of natural gas imported under short-term authorizations continued to eclipse volumes imported under long-term authorizations at all-entry points with the exception of Calais, Maine.

- These three points handled close to 60% of all imports from Canada during the first quarter.

- Continuing a trend of diminishing imports from Mexico in recent years, only a small volume of natural gas was brought into the country from Mexico, through only one entry point, during the first quarter.


Pipeline Exports to Canada by Exit Point


Pipeline Exports to Mexico by Exit Point

The other seven points used during the quarter handled much smaller volumes.

LNG Import Volume by Country



LNG Imports by Terminal, 1Q 2014


