## Description:

- B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

#### Rational for determination:

The County of Monterey, CA would use DOE funds for the following activity which is bounded by the signed SOW and is therefore categorically excluded:

Activity 1, Installation of Photovoltaic System to Service County of Monterey Laurel Yard Facilities.

The remainder of County of Monterey's activities are not included in this SOW and EF1 as they were CX'd at the time of the award, including Activity 2. Investment Grade Energy Audit for County Facilities; Activity 3. Public Energy Efficiency Education Program; Activity 4. Greenhouse Gas Inventory and Tracking System; and Activity 5. Energy Efficiency Ordinance and Incentive Development.
