The U.S. Department of Energy (DOE) provided \$421,000 of federal funding to the State of Oklahoma under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. Oklahoma will match the federal funding with \$46,200 in state funds and \$56,000 from local communities. Additionally, Oklahoma will carry over \$90,000 in federal appropriations, for a total of \$613,200.

Oklahoma proposes to fund the following Market Titles:

Association of Central Oklahoma Council of Governments:

Under this Market Title, Oklahoma would fund education and outreach efforts targeting Central Oklahoma Clean Cities programs that coordinate with technical and community college programs training automotive technology students, who work with advanced vehicle technologies and alternative fuels. It would also coordinate outreach efforts towards fleet managers making decisions on vehicle and fuel purchases.

Energy Smart Communities:

Under this Market Title, Oklahoma would sub-grant funds to local municipalities for energy efficiency measures. The scope of work is unknown and a NEPA review cannot be conducted at this time, therefore, the Market Title is conditioned.

Management:

Under this Market Title, Oklahoma would utilize funding to support the continuing operation of SEP activities performed by Oklahoma personnel.

Revolving Loan Fund:

Under this Market Title, the Revolving Loan Program, funded with appropriations from the American Recovery and Reinvestment Act, would be monitored through funding provided for the Management Market Title. The NEPA Template was signed for this Market Title, any projects that fall outside the bounded categories of the NEPA Template will be submitted for NEPA review/approval.

Tulsa Clean Cities:

Under this Market Title, funding would be utilized to increase awareness of Clean Cities through meetings, events and published materials to support the program goals. It would also support outreach and education of private development for alternative fueling stations.

Based on a review of the activities that would be funded under "Energy Smart Communities" DOE has conditioned this Market Title Pending additional NEPA review. Based on a review of the activities that would be funded under "Association of Central Oklahoma Council of Governments," "Management," and "Tulsa Clean Cities" DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering," and CX A11 "technical advice." Any activities funded by the Revolving Loan Fund that fall outside the bounds of Oklahoma's Template for Expedited NEPA review are conditioned pending additional NEPA review.

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
