Proposed Action Title: (0675-1538) Battelle Memorial Institute - Fault Sensing in Operating Batteries

Proposed Action Description:

Funding will support efforts to develop a novel online, in situ sensor for detecting incipient shorting events in batteries. Proposed work will consist of: (1) design, develop, and fabricate small battery cells, including electrode materials, binders, separators, and electrolytes, and (2) perform electrochemical testing and characterization of full cell and half cell batteries under different conditions.

Project tasks will be conducted by Battelle Memorial Institute and University of Akron in dedicated industrial and university laboratory and office facilities at Battelle Memorial Institute (Columbus, OH) and University of Akron (Akron, OH).

 \checkmark There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion.
