## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Clean Energy States Alliance, Inc. to develop the New England Solar Cost-Reduction Partnership which seeks to reduce soft costs for rooftop solar photovoltaic (PV) by implementing identified best practices across five states. DOE funding would be used to build a strong collaboration among the key agencies responsible for commercializing rooftop solar PV: Connecticut's Clean Energy Finance and Investment Authority (CEFIA), the Massachusetts Department of Energy Resources (MA DOER), the New Hampshire Office of Energy and Planning (NH OEP), the Rhode Island Office of Energy Resources (RIOER), and the Vermont Public Service Department (VT PSD).

Based on review of the project information and the above analysis, DOE has determined the information gathering and technical advice activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with the actions contained in DOE categorical exclusions A9 "information gathering, analysis, and dissemination," and A11 "technical advice and assistance to organizations," and is categorically excluded from further NEPA review.
