A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes to perform routine maintenance on certain wood-pole structures and conduct road maintenance and repairs and re-establish the access road right-of-way (ROW) on the Dave Johnston-Stegall (DJ-SG) 230-kV Transmission Line. The structures were identified as deficient and in need of repair or replacement by Western crews. Work would occur on private and state lands in Converse County, Wyoming.

Routine maintenance actions proposed for the DJ-SG Transmission Line include:

1. The replacement of wood crossarms at structures 1/5, 2/1, 2/2, 6/1, 9/4, 9/5, 9/6, 13/8, 17/1, 17/2, 17/4, and 18/3.

2. Landing construction at structures mentioned above, except at structure 13/8 (See Section D). The landing construction will include grading a level parking area near the structure, approximately 40 feet in diameter, to facilitate level parking and crane truck stabilization and truck turning radius.

3. ROW improvements from structures 6/8 to 7/1 and 11/6 to 11/10.

4. Culvert repair or replacement at structures 5/2, 5/3, 6/8 and 11/9.

This work may be accomplished using a rubber-tired motor grader, track dozer, backhoe, a crane, manlift, backhoe, rubber-tired pressure digger/derrick, skid steer loader, pole trailer, and line trucks. All work will be confined to Western's ROW easements.

B. <u>Number and Title of the Categorical Exclusion Being Applied</u>: (See text in 10 CFR Part 1021, Subpart D.)

B1.3 Routine Maintenance.

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is in-kind and is not a substantial upgrade or improvement. Inkind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for

example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;

(h) Repair of road embankments;

- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeding, gabions, grading, and revegetation);
- (1) Surveillance and maintenance of surplus facilities in accordance with DOE Order 435.1, "Radioactive Waste Management," or its successor;
- (m) Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), and removal of contaminated intact equipment and other material (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) Removal of debris.

C. <u>Regulatory Requirements in 10 CFR 1021.410 (b)</u>: (See full text in regulation and attached checklist.)

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

• Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;

- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).

D. Special Stipulations Pertaining to the Proposal:

This Categorical Exclusion is valid for one year after the signature date. If routine maintenance work has not commenced within that time or the scope of work changes, Western's Environmental Division must be contacted for an updated environmental review.

No ground disturbing activities are allowed near structure 13/8 without further documentation. Any ground disturbance proposed near structure 13/8 will require prior coordination with Western's RMR Regional Preservation Officer.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's RMR Regional Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

To comply with the Migratory Bird Treaty Act, maintenance work shall be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period, contact Western's Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.

All equipment used will be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

Disturbed areas not needed for maintenance access will be reseeded using mixes approved by the landowner or land management agency. Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, or excavation operations, vegetation shall be preserved and shall be protected from damage by Western's construction operations and equipment.

To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No construction or routine maintenance activities shall be performed during periods when the soil is too wet to adequately support construction equipment. If equipment creates ruts in excess of six inches deep, the soil shall be deemed too wet to adequately support construction equipment.

E. <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
