Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis), and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Iowa State University of Science and Technology (Iowa State) to facilitate widespread deployment of Hexcrete towers for harvesting wind energy at 120 and 140 meter hub heights and reduce Levelized Cost of Energy (LCOE) through research and testing of concrete tower technology.

The proposed project activities would involve tower design optimization; development of the Hexcrete concept; structural fatigue testing on a complete Hexcrete section and other key components; project engineering; development of commercialization plans; and concrete tower hull prefabrication. Iowa State would partner with Siemens Corporation, BergerABAM, Inc., Coreslab Structures, Inc., and the Multi-Axial Subassemblage Testing Laboratory of the University of Minnesota to complete the proposed project objectives. All proposed activities would consist of paper-based research, computer modeling, data collection and analysis and laboratory operations. Existing corporate and University health and safety policies and procedures would be followed including employee and student training, proper protective equipment, engineering controls, monitoring, and routine internal assessments. The facilities where development, fabrication and testing activities would occur are designed for this type of research; therefore, no new construction, modifications or new permits, additional licenses and/or authorizations would be required as result of the proposed project.

Based on a review of the project information and the above analysis, DOE has determined that the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that this project is consistent with actions outlined in DOE categorical exclusion A9 "information gathering" and B3.6 "Small-scale research and development, laboratory operations, and pilot projects" and is therefore categorically excluded from further NEPA review.
