**WEATHERIZATION PROGRAM NOTICE 09-10**  
**EFFECTIVE DATE: October 6, 2009**

**SUBJECT:** WEATHERIZATION ASSISTANCE PROGRAM DATA COLLECTION

**PURPOSE:** To inform Grantees that, over the course of the next few days, representatives from the Department of Energy (DOE) will be conducting a one-time data collection to provide real-time information and ensure program transparency.

**SCOPE:** The provisions of the guidance apply to Grantees receiving American Recovery and Reinvestment Act (Recovery Act) financial assistance under DOE Weatherization Assistance Program (WAP), as well as their Subgrantees. Territories and tribal recipients of WAP Recovery Act funds are not subject to this data collection.

**BACKGROUND:** WAP is at another milestone where we need your assistance as well as your due-diligence. Over the course of the next few days you will be contacted by DOE representatives who will be requesting information from you in regard to the WAP program in your state. Contacts will be in the form of telephone inquiries. We are asking you to respond to them, and help us in regard to keeping our program as transparent and equipped with as much "real time data" as possible.

The data collection will be organized as a two step process:


1. DOE representatives will call the 50 state Grantees and ask them to collect and provide data on their activities, as well as data from all of their Subgrantees. If Grantees do not have the Subgrantee data or cannot quickly obtain the information from Subgrantees, DOE will call Subgrantees directly in those states.
2. For those states that cannot provide Subgrantee data, DOE will call a sample of local agencies that represent the majority of distributed WAP funding.

Please note: DOE representatives will be directly contacting Subgrantees in the next 24 hours to inform them of this data collection effort.

The questions we will be asking are attached for your review and convenience in order for you to be prepared when our DOE representatives call. These questions and your reply are needed to give us here at DOE a better understanding of your programs as to where you are now and where you will be in the next few months. We are trying to analyze your needs and we plan on offering assistance where needed, but we require your help in accomplishing this task.

Thank you for your patience and the work that you have done thus far for WAP. The WAP portion of the Recovery Act will go a long way toward putting America back on its feet again in the upcoming months, and you will play a key role in the success of this effort. It is a pleasure to work with you on this important challenge. I look forward to the growth of this Program and our continued partnership to ensure *Weatherization Works!*
