RE: Supplement Clarification Document to Application 14-79-LNG

Please consider this supplement clarification document from CLEANCOR Energy Solutions, LLC (CLEANCOR) our official clarification to Application 14-79-LNG for the proposed export of liquefied natural gas (LNG). Below is an outline of the items at question as well as additional clarification of the proposed operation for this two (2) year proposed blanket authorization.

CLEANCOR is seeking authorization to export LNG to both Mexico and Canada via truck and via ISO units to Free Trade Agreement (FTA) Countries deemed public interest export under Section 3c of the NGA as amended by section 201 of the Energy Policy Act of 1992 (PUB. L. 102-486). CLEANCOR proposes to export to FTA Countries using approved LNG-rated cryogenic International Organization for Standardization ("ISO") approved (ISO IMO7/TVAC-ASME) cargo containers transported on ocean going vessels. CLEANCOR proposes to export the LNG from existing container terminals in but not limited to the Port of Jacksonville and Port Everglades, FL.

CLEANCOR is seeking authorization to export up to 4.95 Bcf during this two (2) year blanket authorization. CLEANCOR will contract with existing liquefaction facilities with existing loading racks and transport the LNG via truck to end users in Mexico and Canada. CLEANCOR will also transport the LNG via LNG-rated ISO container units to terminals in the United States where the ISO units will be loaded onto ocean going vessels and delivered to end users in FTA Countries. CLEANCOR will deliver the LNG to the downstream users in Mexico and Canada via truck and to customers in Countries where the United States has or will have approved FTA agreements via ISO units.

CLEANCOR will contract with, but not limited to, Pivotal LNG, Inc., a wholly-owned subsidiary of AGL Resources, a major US energy company, with operations in natural gas distribution, retail, and wholesale markets. Under this agreement, CLEANCOR proposes to export domestically produced LNG from Pivotal's existing liquefaction production facility in Trussville, Alabama as the main source of LNG but will also contract with other approved liquefaction production facilities existing or that will exist during the term of this blanket authorization. Currently, the Pivotal Trussville facility has the capability of loading LNG into trucks and ISO units thus no additional infrastructure will be required.
