American Recovery and Reinvestment Act:

1) Continuation of the use of technical services to support energy efficiency planning, 2) performance of energy audits on residential housing and small commercial buildings including an outreach program concerning the audit program, 3) development and implementation of a Property Assessed Clean Energy Bond Program and a revolving loan/grant program to support energy efficiency retrofitting by residents and businesses, 4) installation of energy efficiency retrofits in city-owned buildings and facilities (APPROVAL EXCLUDES ACTIVITY 4), 5) performance of energy audits of city-owned buildings and facilities, 6) development and implementation of an energy efficiency and conservation education and outreach program, and 7) adoption, implementation, and enforcement of a revised city building code incorporating the Louisiana Energy Efficiency Building Code (including training, purchase of equipment, update of code books, etc.) and training of city inspectors to also be Home Energy Rebate Option Raters
