## Proposed Action or Project Description

American Recovery and Reinvestment Act:

1) Develop energy efficiency and conservation strategy which includes conducting energy audits and utilizing EPA's Portfolio Manager to compare energy performance levels on buildings; 2) technical consultant services to conduct energy usage audits on county buildings; 3) building retrofits on the Animal Control Facility which includes replacing windows, insulation, door seals, and door closers, and installing a solar hot-water heater for potable water and space heating; 4) building retrofits on the Administration Building to include replacing rooftop heating and cooling equipment with new seer-rated equipment; 5) building retrofits on the Judicial Complex which includes performing testing to determine programming and design changes needed for building equipment management software and installation of ambient lighting controllers and programming changes to the lighting control panel including rewiring and new controls; and 6) installation of a 9 kW solar panel system on the roof of the Animal Control Building
