Description:

- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- A11** Technical advice and planning assistance to international, national, state, and local organizations.
- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

**Rational for determination:**

The City of San Antonio, TX would use DOE funds for the following activities which are bounded by the signed SOW and are therefore categorically excluded under NEPA:

Activity 7: Solar Installation for Airport

This solar project will be roof-mounted on the airport existing Long-Term Parking Garage. The City originally received a CX on this project. However, they dropped a separate project, Convention Center PV project, and transferred funds to this PV Airport project. As a result they increased the scope of this project and the electrical capacity from 175 KW to 245 KW.

Any projects submitted for EECBG funding that fall outside the bounds of the signed SOW will require a separate NEPA determination review.
