Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The State of Louisiana will provide \$10,000 in Recovery Act funds to Control Tech, LLC to off-set equipment purchase costs for a planned compressed natural gas station in the Lafayette, LA area. The Station and supporting infrastructure will be constructed at 98 Bayou Drive, New Iberia, LA.

Acadiana is a region of south Louisiana comprised of 22 parishes with Lafayette being at the central point. Although it is not within the scope of this project, the greater objective is to set up a central site for Lafayette and surrounding Parishes for alternative fuel solutions for Light duty vehicles, Heavy Duty vehicles, and Emergency Power Generation Systems. The Control Tech site ultimately intends to have an infrastructue capable for the CNG conversion of fleet trucks or commercial vehicles.

The current project is to install two (2) BRC Fuelmaker fueling systems, one a fast-fill compressed natural gas filling station and the second a propane filling station. The systems are to be accessible to the public. All tanks will be located above ground; no ground excavation is required. The current road infrastructure appears sufficient to handle the anticipated increase in traffic; the size of the facility would not seem to warrant the need for road improvements.

The area is best characterized as remote, but there is a mix of residential and commercial properties in the vicinity. The facility will be constructed in an unpaved, gravel covered area adjacent to Control Tech's corporate office. The station will tap into an existing natural gas line on the property. Wetlands exist to the east (approximately 300 yards) and south (approximately 150 yards) of the proposed facility. DOE does not envision that the installation or operation of the facility will likely impact either wetland.

In view of the information provided by the State and recipient, DOE has determined that work outlined is consistent with activities identified in Categorical Exclusion B5.1.
