Proposed Action or Project Description

American Recovery and Reinvestment Act:

1) Conduct energy audits on the residences of Cherokee Citizens with both privately owned residences and tribal managed housing; 2) develop a comprehensive energy policy that would encompass the Tribal government as well as its business entities; 3) construct Recycling Center Facility (150 ft x 75 ft) which includes an internal office area and purchase and install locker storage bins; 4) locate a compressed natural gas fuel station on an existing, conventional filling station, adjacent to the Cherokee Nation Tribal Office to fuel motorized vehicles, 5) conduct building retrofits on Cort Mall, Tahlequah (includes retrofitting with an energy efficient shell system consisting of a roof, insulation, flashings and sheet metal, applying sealants, installing special energy efficient doors and windows and special glazing treatment; replacing HVAC systems; replacing hot water heaters and plumbing fixtures; electrical system replacements/upgrades; lighting replacement/upgrades; and installing a programmable lighting control system/control panel); 6) locate a compressed natural gas facility on an existing, conventional filling station at Roland in Sequoyah County to fuel motorized vehicles; 7) conduct building retrofits to the Old National Prison (including doors and windows, thermal and moisture protection added to the building, plumbing retrofitted, HVAC unit replaced and system reconditioned, and inside and outside electrical systems to be retrofitted to accommodate the new HVAC system); 8) conduct building retrofits to the Old Ross School Building (including doors and windows, thermal and moisture protection added to the building, plumbing retrofitted, HVAC unit replaced and system reconditioned, and inside and outside electrical systems to be retrofitted to accommodate the new HVAC system); 9) conduct building retrofits to the Old Capital Building (including replacing the HVAC unit and reconditioning the HVAC system and retrofitting the electrical system in the building and in the basement to accommodate the new HVAC system); 10) retrofit the Learning Services Building with new doors and windows, install a thermal moisture protection to the building, and replace the HVAC units; and 11) retrofit the WPA Building with a new roof, door and windows, install a thermal moisture protection to the building, and replace the HVAC units.
