Proposed Action or Project Description

American Recovery and Reinvestment Act:

1) Perform energy audits on six city-owned facilities 2) complete EE retrofits--replace garage door at the Traffic Division Facility, 3) install day/lighting controls and window solar covers to Showers City Hall Building, 4) add blown-in fiberglass insulation to attic of Bloomington Fire Department Headquarters, 5) optimization of HVAC systems, ductwork repair, install insulation, and modify the lighting system from metal halide to fluorescent units at the SportsPlex Community Center, 6) install new LED street lights, and 7) purchase and install solar trash compactors reducing the number of garage pick-ups in downtown area.

Conditions: None
