American Recovery and Reinvestment Act:

1) Develop an energy efficiency and conservation strategy (completed), 2) acquire technical services to develop an ongoing energy efficiency and management program, 3) perform Energy efficiency retrofits to six city-owned buildings, 4) install traffic light controller and camera at several intersections, 5) replace 24 high pressure streetlights with energy efficient LED fixtures
