Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Hire consultant to update the City's General Plan; 2) institute a solar/photovoltaic system rebate program; 3) traffic light synchronization program; 4) building inspector and personnel training on building code standards; 5) retrofit lights city parking lots with energy efficient LED lighting and convert traffic signals to LED fixtures; 6) replace HVAC units at Murrieta Community Center and install automation system user interface upgrade on city facilities; 7) remove old, lighted street signs and install new reflective street signs; 8) lighting retrofits in city facilities to replace inefficient lighting with energy efficient lighting, install occupancy controls/sensors, and technical consultant services to conduct lighting study; and 9) install window tinting or solar blocking window blinds in city facilities.
