American Recovery and Reinvestment Act:

The Cocopah Indian Tribe of Arizona proposes to perform building retrofits on the Tribe's Community Center (built in 2004). Retrofits would include replacing lights and sensors with more effective and efficient products, replacing faulty doors, replacing inoperable air conditioning units with more efficient ones, and retrofitting existing windows to be more energy efficient.
