Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

## CX, EA, EIS APPENDIX AND NUMBER:

# Description:

- B3.1 Onsite and offsite site characterization and environmental monitoring, including siting, construction (or modification), operation, and dismantlement or closing (abandonment) of characterization and monitoring devices and siting, construction, and associated operation of a small-scale laboratory building or renovation of a room in an existing building for sample analysis. Activities covered include, but are not limited to, site characterization and environmental monitoring under CERCLA and RCRA. Specific activities include, but are not limited to:
- B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.
- A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

## Rational for determination:

DOE is proposing to provide federal funding to Pueblo of Jemez (Jemez) to develop and demonstrate geothermal resource on the Pueblo of Jemez Reservation.

This NEPA determination applies to Task 4.1 (Phase II) and Tasks 5 and 6 (Phase III) only. DOE has completed NEPA determinations for Tasks 1 – 3 (Phase I and II) and will complete additional NEPA review of Phase II Task 4.2 when sufficient information is available and after the go/no go decision. The tasks covered by this NEPA determination are described below.

Task 4.1 (Phase II) Drill Exploration Well – Based on the information gathered in previous phases and tasks, Jemez would drill the first exploration well and conduct logging runs and analysis.

Task 5 (Phase III) Well and Reservoir Testing – Jemez would conduct detailed well testing including an innovative tracer test and a test of flowing electrical conductivity (FEC), to determine the fracture surface area, heat content and heat transfer, flow rates, and chemistry of the geothermal fluids encountered by the exploration wells.

Task 6 (Phase III) Project Management and Reporting

A Class III Cultural Resource Survey (completed June 28, 2010) and a Biological Assessment (completed June 17, 2010) for the Seismic and Magneto-Telluric Survey Sites (Task 2) and geothermal wells indicates no effect to threatened or endangered species, floodplains, wetlands or significant cultural resources. Cultural resources are marked and identified which would be avoided by routing the lines and geothermal wells around the cultural sites.

A go/no-go decision would be made after testing the first exploration well (Task 4.1) and prior to drilling the second well (Task 4.2). This go/no-go decision would be based on data analysis from the first well including geothermal reservoir temperature, geochemical analyses of well-fluids, and permeability.

Task 4.2 is prohibited at this time and subject to additional NEPA review by DOE.
