Rational for determination:

This NEPA determination applies to Phase 2. DOE is proposing to provide federal funding to the Houston Community College System (HCCS) to continue developing the solar "train-the-trainer" program. DOE funds would be used to support the education, training and professional development of solar instructors.

DOE made a previous determination for Phase 1 (GFO-10-234; CX A9 and B5.1; signed 2.23.2010). Phase 1 included purchase of one mock up roof that is assembled for training purposes and then disassembled and stored inside.

HCCS proposes to further develop a collaborative process used to train solar instructors. The training would involve co-teaching arrangements for new instructors to gain teaching experience, instructor training courses, expand training to include code and building officials, resource development groups that share best practices and develop collaborative agreements with other Regional Training Providers. Through this process, HCCS would refine and expand this training program in partnership with other organizations throughout the Midwest.

Based on this information, DOE has determined the work outlined is consistent with activities identified in categorical exclusion A9 (information gathering), A11 (technical advice and assistance to organization) and B3.14 (small-scale educational facilities).
