

**ENVIRONMENTAL REVIEW FOR CATEGORICAL EXCLUSION DETERMINATION**

**Midway Substation 230-kV Upgrades**

- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to modify components within the Midway Substation 230-kilovolt (kV) yard to accommodate upgrades being performed by Tri-State Generation and Transmission Association, Inc. Western's proposed modifications would occur entirely within the fenced perimeter of the substation located in Township 17S, Range 65W, Section 20 of El Paso County, Colorado.

Western would re-conductor the main and transfer strain buses with 1,272 kcmil (thousands of circular mils) Aluminum Conductor Steel Supported (ACSS) at the Midway Substation. The duplex 1,590 kcmil All Aluminum Conductor (AAC) jumpers on each bay in the substation would be installed. The substation fittings, pedestal insulators, and tension insulator string would be replaced to accommodate the higher temperature rating of the ACSS conductor. Western would replace the existing Lincoln and transfer bays 1,200 amp rated switches 281, 283, 285, 383, and 385 with 2,000 amp switches. The Lincoln and transfer bays rigid 4-inch aluminum conductor and associated connections would also be replaced.

**B4.6 Additions and modifications to transmission facilities.**

**Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area.** Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), **changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.**

Construction or modification of **electric power substations** or interconnection facilities (including, but not limited to, switching stations and support facilities)

- C. **Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to; those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western's Environment Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 1 year after the signature date. If construction has not commenced within that time, Western's Environment Division must be contacted for an updated environmental review prior to construction.

The findings of this Categorical Exclusion depend on the contractor's execution of, or compliance with, Western's construction specifications for the project, specifically, Division 13 – Environmental Quality Protection.

If any cultural materials are discovered during construction, work in the area shall halt immediately and Western's Environmental staff shall be contacted.

- E. Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
