II. Project Description and Location (including Time Period over which proposed action will occur and Project Dimensions - e.g., acres displaced/disturbed, excavation length/depth, area/location/number of buildings, etc.):

CH2MHill Plateau Remediation Company (PRC) will be conducting siting, construction, and operation of support buildings and support structures on and near the Hanford Site in accordance with the categorical exclusion (CX) referenced in 10 CFR 1021, Appendix B, CX Bl.15, "Siting, Construction, and Operation of Support Buildings and Support Structures". PRC Projects include all those identified Sections J.13 and J.14 of the PRC Contract, DE-AC06-08RL14788.

Annual activities would include, but not be limited to:

Siting, construction and modification, and operation of new buildings and support structures (including but not limited to trailers, pre-fabricated and modular buildings, mobile office, portable restroom trailers, connex boxes, dumpsters, waste disposal containers and ERDF roll-off boxes.

Covered support buildings and structures include those for office purposes, parking, routine maintenance activities, storage of supplies and equipment for administrative services; security, fire protection and similar support services but excluding facilities for waste storage activities.

Additional activities necessary to support use of these structures such as:

- Construction of small septic tank systems, electrical connections (to either a portable generator or on-site power), water connections, telephone and HLAN connections, installation of stairs/stairway, ramps, skirting, tie-downs, and construction of parking lots, walkways, and lighting as needed to accommodate access and support operations.
- Modification of heating, ventilation, air conditioning (HVAC) systems.
- Moving or relocating equipment, trailers and any other materials necessary to implement or support the proposed actions.

Prior to work, all locations will be evaluated to determine if ecological/biological or cultural reviews are needed.




