Tracey LeBeau

Tracey A. LeBeau (Cheyenne River Sioux) is Director for the U.S. Department of Energy's Office of Indian Energy Policy and Programs. She was appointed in January 2011 to establish this new Office, which is authorized by statute to manage, coordinate, create, and facilitate programs and initiatives to encourage tribal energy and energy infrastructure development. Administratively, the Office was established to also coordinate, across the Department, those policies, programs, and initiatives involving Indian energy and energy infrastructure development.

Pilar Thomas

Pilar Thomas (Pascua Yaqui) is the Deputy Director in the Office of Indian Energy Policy and Programs. As Deputy Director, Ms. Thomas assists the Director in developing national energy policy and programs related to Indian energy development. Ms. Thomas is also responsible for developing and implementing policy efforts within the Department and federal government to achieve the Office's Indian energy policy objectives.

Confederated Tribes of Warm Springs

Jim Manion

Jim Manion is currently the General Manager for the Confederated Tribes of Warm Springs energy enterprise, which oversees the operation of the tribe's interest in the Pelton Round Butte Hydroelectric Project. Mr. Manion also is responsible for oversight on energy development activity on the 650,000-acre tribal land base. He has lead the tribes in negotiating right-of-ways including two high voltage transmission corridors and one proposed natural gas crossing. As a tribal member raised on the Reservation, his knowledge of tradition and tribal culture, mixed with contemporary business management capacity and skills, provides Mr. Manion with a unique vision for balancing economic development, natural resource protection, and cultural preservation.

National Renewable Energy Laboratory

Dan Beckley

Dan Beckley is a Principal Laboratory Program Manager at the National Renewable Energy Laboratory (NREL). He provides oversight and guidance for the NREL Office of Indian Energy Policy and Programs project team. Mr. Beckley was a Presidential Management Fellow in the U.S. Department of Energy's Office of Energy Efficiency and Renewable Energy prior to joining NREL.
