

ADVISORY ALERT: Dekker, Ltd. Digital Signature – PARS II Reporting

As you know, to run reports in the PARS II, users must install an active X control to their workstations. The **FIRST TIME** a user attempts to run a report after installing the Active X control, a Security Warning will appear stating:

Security Warning: Some active content has been disabled.

That warning appears because, although the digital signature is valid, the digital signature is from a publisher (in this case Dekker, Ltd.) whom you have not yet chosen to trust. The following steps instruct you how to clear the security warning so that you may continue working with PARS II reports.

Please note: Once you complete the process of accepting the Dekker, Ltd. digital signature, this warning will not re-appear. This process must be done **ONCE** to “inform” your PC that Dekker, Ltd. is an acceptable, trusted site for your PC.

STEPS TO CLEAR THE SECURITY WARNING:

1. When the Security Warning appears, click on Options

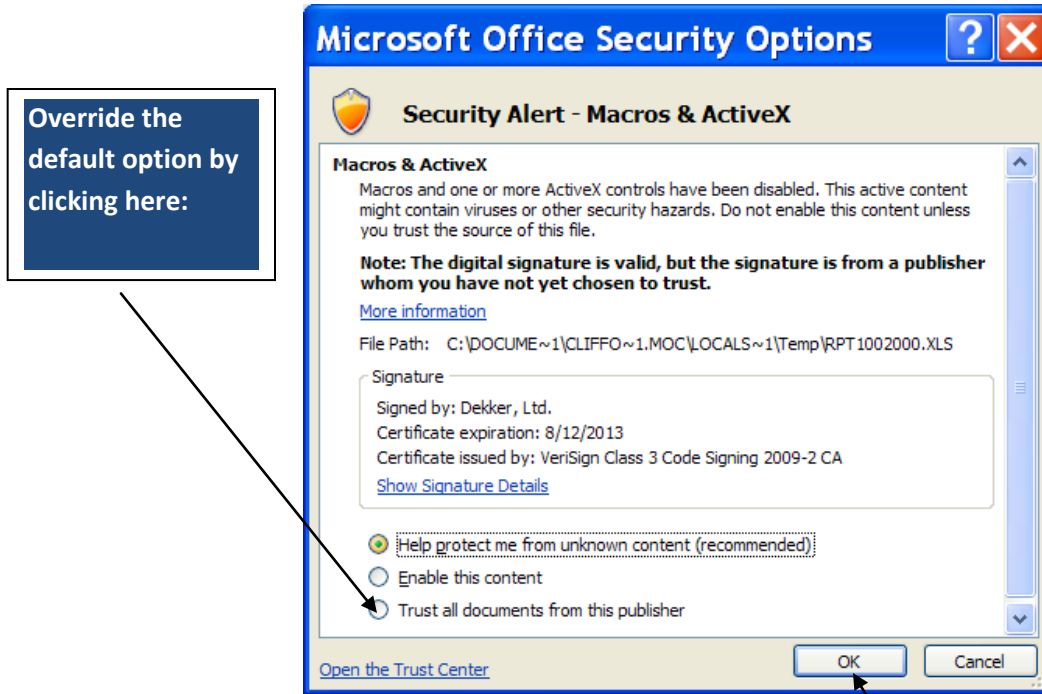

2. Clicking on the options tab returns the following screen:

Note that the return screen has pre-selected the default option “Help protect me from unknown content (recommended)”. **Do not select the default option.** Select “Trust all documents from this publisher “ by clicking on the button next to that selection as shown in the next screen:



3. Once you select “Trust all documents from this publisher, select OK. Once you select OK, the screen will disappear as you have selected Dekker, Ltd, as a trusted source.

You may return to working in the PARS II Reports function.
