Communication Channels and Protocols:

- John Makepeace put together a communication channel diagram for the deployment phase of PARS II. Mr. Makepeace presented the chart to the group. EES/Dekker will need to have communications directly with the contractors. All communications must be CC'd to the program leads.
- EM already has its own IPT, which is something that the other programs may want to emulate. IPTs for the individual programs would include site leads from the participating sites within the individual program.
- EES is the prime contractor, Dekker is a big part of this, but EES is the lead, so all communications must be managed and known by them.

Project Priorities:

- OECMC has received the list of project priorities from EM and NNSA, but not from Science.
- EM is confident that their list of projects will change due to overall restructuring of the program.

High-Level Schedule Milestones:

- Ken Henderson presented the milestones in the accompanying slide on this topic.
- "Early Look" demos of the system will commence in early December for OECM.
- One person from each program and the OECM personnel and a few FPDs will be the User Acceptance Testing group, which will total about 12 people. They will all be in the same room either in Germantown or downtown DC, to test the OA and CPP modules. This will be on the real AHE server, in the test environment.
 - A couple UAT testers will be at their own site, to make sure such access is verified.
- There will be a defect reporting form and issues will be classified using the "PARS II Problem Classification" scheme (discussed later in this meeting).
 - Any defects discovered will be retested after being corrected.
- Brian Kong asked for an early look demo sooner than December.

PARS II Problem Classification:

- There will be a defect form for the acceptance testers to fill out and classify items that they find wrong with the system as follows (the USERS/TESTERS determine the level, not the help desk personnel):
 - o 1 (RED): Prevents the Accomplishment of an Essential PARS II Capability
 - 2 (RED): Adversely Affects the accomplishment of an essential PARS II capability, and no work-around solution is known
 - 3: Adversely affects the accomplishment of an essential PARS II capability, but a work-around solution is known
 - 4: Results in User/Operator inconvenience or annoyance, but does not affect an essential PARS II capability
 - o 5: Any other effect
- Red items will present immediate schedule impacts to the deployment, as they are considered critical fixes that must be made in order to continue deployment.
- Several non-red items may also cause schedule impacts if they are enough in number to slow down deployment.
 - o E.g. too many related 3s could ultimately be qualified as a 2.
- Issues encountered during the UAT will be handled on a case-by-case basis.

Moving to Weekly IPT Meetings:

- Ken and John suggested holding the meetings every week because during the deployment many more stakeholders would be involved and things would be moving rapidly, requiring the need for communication to be more "real time".
- Ken also stated the need for the format of the IPT would shift from delivering presentations to working on issues and deciding on actions to keep the deployment moving along productively.
- The attendees in the room and on the phone agreed to the weekly schedule.

Additional Topic of Discussion – Preliminary Information Package Needs to Go Out to the Contractors:

 Pete Check initiated a discussion about the programs creating a contract requirement on their own, rather than creating one at the DOE HQ level. Contract mods work much

- more quickly coming from the programs themselves. EM has already done this for their contracts.
- The contractors should not have to wait for their kickoff meetings in order to see the
 preliminary information package. OECM will provide the IPT members with the CPP
 package next week at the IPT meeting. Once the programs distribute this information to
 the contractors, the contractors will be better able to provide their programs with the
 estimated effort it will take to comply.
- Pete Check suggested that the information package must have a cover letter memo that
 markets the PARS II requirements to the contractors, and lets them know why this is "the
 best thing since sliced bread." EES will send this package and letter to OECM next
 Monday, which will review it before next week's IPT meeting.
- Mike Nosbisch suggests that some of the benefits to contractors of this system may be
 that other reporting requirements may be alleviated by this tool. Pete Check agreed,
 and asked that this investigation be placed on the Parking Lot to look into what other
 requirements can be met by this system. John Makepeace asked FCOG to put together
 a list of required reports that they have to provide now, and send the list to OECM for
 review.

- 11. Pete Check will follow up with the Office of Science regarding their response to the Project Priority List, which was due to OECM a week ago.
