Tri-Valley CAREs would like to formally request copies of the charts for the stockpile life extension programs (LEPs) from 2005 to the present These charts feature information on every weapon type in the stockpile, including every LEP planned, a description of the LEP, the proposed year for the LEP, and why it is planned.

In the event that access to any of the requested records is denied, please note that FOIA provides that "[a]ny reasonably segregable portion of a record shall be provided to any person requesting such record after deletion of the portions which are exempt under [FOIA]." 5 U.S.C. § 552(b). Tri-Valley CAREs therefore requests that it be provided with all non-exempt portions of the requested records that are reasonably segregable. Tri-Valley CAREs further requests that you describe the deleted material in detail and specify the statutory basis for the denial, as well as your reasons for believing that the alleged statutory justification applies in each instance. Please separately state your reasons for not invoking your discretionary powers to release the requested documents in the public interest. Such statements will be helpful in deciding whether to appeal an adverse determination and in formulating arguments in case an appeal is taken. DOE's written justification might also help to avoid unnecessary litigation. Of course, Tri-Valley CAREs reserves its right to appeal the withholding or deletion of any information.

Tri-Valley CAREs requests a waiver of all fees for this FOIA request. Disclosure of the requested information to Tri-Valley CAREs is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in our commercial interest. Tri-Valley CAREs meets the fee waiver criteria set out in 10 C.F.R. § 1004.9:

1. Whether the subject of the requested records concerns the "operations or activities of the government."

The Department of Energy (DOE) and its operations and activities—including the stockpile life extension programs—are operations and activities of the government.

Disclosure of the requested records will contribute to an understanding of government operations and activities. The National Nuclear Security Administration (NNSA), a separately organized agency within DOE responsible for the management of the nation's nuclear weapons, must develop individual life extension programs for each weapon type and develop specific solutions to extend the lifetime of each particular warhead or bomb. This includes identifying and correcting potential technical issues with each weapon and then refurbishing and replacing certain components as necessary. These efforts are intended to extend the lifetime of a warhead or warhead component for an additional 20 to 30 years. The requested documents provide important details about the LEPs and so will contribute to an understanding of government operations and activities.

3. What contribution to an understanding by the general public will result from disclosure?

Tri-Valley CAREs uses information obtained through FOIA to help the general public and others understand the operations and activities of the government, specifically DOE and its Lawrence Livermore National Laboratory. Tri-Valley CAREs publishes a monthly newsletter, circulated free of charge to interested parties. Information obtained from FOIA requests is used in the newsletter to increase public understanding of DOE activities, and it is expected that information obtained through this request will be used in our newsletter.

In addition, Tri-Valley CAREs uses information derived from FOIA requests in its fact sheets, reports, and other materials that are distributed, like our newsletter, to the media, elected officials, regulatory agencies, other organizations, and the general public. Information is also available on our web site at http://www.trivalleycares.org. Moreover, information provided by Tri-Valley CAREs is used regularly by local, regional, and national media.

Tri-Valley CAREs seeks these records in order to inform the public about important government operations and activities regarding the nuclear weapons complex. Again, the requested records contain information regarding the life extension programs for each weapon in the nuclear weapons arsenal. Disclosure of this information will facilitate public understanding of the current state of the nuclear weapons arsenal and efforts to ensure the future viability of these weapons.

By obtaining these records, Tri-Valley CAREs will benefit the public and contribute to its general understanding. This is the group's mission, as laid out in its articles of incorporation and its 501(c)(3) status.

4. Whether the disclosure is likely to contribute "significantly" to public understanding of government operations or activities.

Disclosure of the requested documents will contribute significantly to public understanding of the government's operations and activities regarding each warhead or bomb in the nuclear weapons arsenal. These records will disclose any identified technical issues that may affect the performance of each weapon type, as well as the government's plan to extend the lifetimes of the nation's nuclear weapons.

Additionally, Tri-Valley CAREs has the means (see #3 above) and the track record to be "likely to contribute 'significantly' to public understanding."

5. Whether the requester has a commercial interest that would be furthered by the requested disclosure.

This is not applicable in the case of Tri-Valley CAREs. As mentioned, Tri-Valley CAREs is a 501(c)(3) public benefit organization. We provide the information to the public free of charge.

In light of the above, Tri-Valley CAREs requests a fee waiver for the disclosure of this information.

Tri-Valley CAREs asks that our request receive expedited processing because there is a compelling need for these documents. Currently, NNSA is in the process of preparing the final Complex Transformation Supplemental Programmatic Environmental Impact Statement (SPEIS). That document outlines NNSA's vision for the nuclear weapons complex and important changes to the complex may result from its issuance. The requested records provide information that is essential to assessing the relative merits of NNSA's plan and evaluating the proper direction for the nuclear weapons complex. Accordingly, this request should receive expedited processing.



My interests are to defend myself against false accusation; restore my name and reputation following false and malicious accusations made against me to the FBI-JTTF, DOE, and the University of Tennessee, and to publish an account of how research that would have been of national interest pertaining to social perceptions of risk related to depleted uranium, and which was funded by the University of Tennessee, led to my being subjected to federal investigations based on false and malicious accusations.

an imminent threat to the life or physical safety of an individual exists or

Specific Justification for Expedited Processing:

has accused me of attempting to obtain classified information pertaining to the transport and storage of uranium, and said that she fears that if I do not obtain the information from her, that I will otherwise obtain it and "frame" her. Not only is this information utterly false and malicious, but by way of making these accusations public and communicating these claims to the campus community, she is suggesting that I have violent intentions. My safety is therefore in jeopardy if people sincerely believe her accusations to be true, and University of Tennessee administration has publicized her accusations by way of including them in my tenure dossier and requesting that the faculty evaluate my fitness as a faculty member based on these preposterous claims that I have engaged in efforts to obtain nuclear materials which they have suggested was for the intent to build a hydrogen bomb. The FBI-JTTF thoroughly investigated this matter and found no basis to pursue these charges; my research was terminated; and I fear for the safety of myself and my daughter with these allegations having been made public. I am completely innocent of any charges of violent intent, much less unlawful or unethical behavior. I never discussed work in any detail, never ever asked of her any information regarding classified material, and had only a vague understanding of her work responsibilities until googling her today, September 12, 2008, because I never wanted to suggest to her in any way that she compromise her professional ethics in the course of her research. I believed her when she said she wanted to conduct research under my supervision wholly unrelated to her work with DOE, and while I did express potential research directions that could build on her expertise (which I understood to be related to radioactive waste inspection), I never, ever, ever suggested she provide me classified information, or even implied such a possibility in jest or otherwise. I am totally innocent of any accusations of unethical or unlawful behavior, and not only wish to clear my name, but to bring to light the difficulties facing researchers who focus on issues of value and relevance to national security. I have devoted my life to the principles of democracy, the U.S. Constitution, peace, and national security and would never breach those principles. Indeed, I have publicly criticized the anti-war movement for its failure to advocate for better national security of our ports, chemical industries, food supplies, oil refineries and other strategic assets, and would never, ever knowingly seek, publish or communicate any classified information. I believe that the nature of my research, combined with petty office politics, led me to be set up for false accusations that have not only devestated me professionally and financially, caused irreperable harm to me and my small daughter (who also accused of plotting violence involving a plate of chocolate chip cookies, which she communicated to law enforcement),

but by way of her false accusations, have terminated research that had the potential for advancing U.S. national security interests because I do not believe (contrary to a misleading edited documentary of my views) that the use of depleted uranium is a form of nuclear warfare. I believe that the use of DU is an issue of environmental justice and concern, but is not in any way the "genocidal" or "nuclear" hazard that has been represented in the press and by anti-DU advocates. My research findings supported in large part the findings and views of the DoD and World Health Organization. Thus, accusations, whether for personal interest or because she may have been sent to "spy" on me as she would joke, are not only false and have jeopardized my safety by communicating to the university that I am intending terrorist actions againt the government, but they have cost the U.S. taxpayers unnecessary costs to investigate, and have terminated a research project that had value to the United States security interests.

Judicial Watch exists to educate the public about the operations and activities of government, as well as to increase public understanding about the importance of ethics and the rule of law in government. The particular records requested herein are sought as part of Judicial Watch ongoing efforts document the operations and activities of the federal government and to educate the public about these operations and activities.

Courts applying the "public interest" fee waiver provision of FOIA typically take into

account four factors in determining whether to grant a waiver: (1) whether the subject of the requested records concerns the operations or activities of government; (2) whether disclosure of the requested records is likely to contribute to an understanding of government operations or activities; (3) whether disclosure of the requested records will contribute to a "reasonably broad" audience and whether the requestor has the "ability and intention" to disseminate the information to the public; and (4) whether disclosure of the requested record will contribute "significantly" to the public understanding. See D.C. Technical Assistance Org. v. HUD, 85 F. Supp.2d 46, 48-49 (D.D.C. 2000); 28 C.F.R. § 16.11(k)(2)(i)-(iv). Request for "public interest" waivers are to be judged on a case-bycase basis." Larson v. CIA, 843 F.2d 1481, 1483 (D.C. Cir. 1988).

The subject of the requested records necessarily concerns the operations or activities of the government. Regional and energy security were threatened with the conflict between Georgia and Russia. *CNN* reports that Vice President Cheney has recently visited Georgia and offered U.S. assistance to the nation. The requested records will presumably demonstrate the extent of U.S. involvement in Georgia and any influence energy has on such involvement.

On the third point concerning the Alaskan pipeline, the requested records pertain to a highly expensive endeavor. The pipeline is estimated to require federal government funding according to the Governor of Alaska's Gas Inducement Act website. The records will clarify the extent of U.S. federal government involvement in the project and elucidate a future use of tax payer money.

Disclosure of the requested records will necessarily contribute to an understanding of operations. Without the records, any discussion of either the Georgia pipeline or the Alaska pipeline remains nebulous. Disclosure of records related to the first 2 points (concerning Georgia) will contribute to an understanding of U.S. energy security and U.S. involvement as pledged by Vice President Cheney to the nation. Prior to August 2008, Georgia was a little known nation to most Americans. Nonetheless, the pipeline involves 2 American companies and a commodity that the United States is deeply dependant on.

Similarly, disclosure of records relating to point 3 (Alaska pipeline) will contribute to understanding estimated costs of securing domestic energy. Such "bridge shipper" activity provokes questions about the efficiency of domestic energy sources and the efficiency of such a project. The possible U.S. funding also provokes questions of whether it is in the United States' interest for one state to commit to such a project that has ramifications for the rest of the country. Only disclosure of the records will detail what those ramifications are and what to expect from the federal government with the pipeline project.

Disclosure of the requested records for all three points will appeal to a broad audience and the information will be disseminated to the public. With gas prices dominating the news and affecting all Americans daily, a broad audience is certainly interested in all aspects of the U.S. energy situation including the pipelines in Georgia and Alaska. This audience is interested to know what the U.S. government is doing to reduce dependence on Middle Eastern oil. Moreover, with the current involvement in Iraq, Americans are interested in how U.S. energy goals affect U.S. foreign policy. At the same time, with the conflict between Georgia and Russia over South Ossetia and Abkhazia, many Americans began to show an interest in the region that they had not demonstrated for several years as can be seen by the news coverage of the conflict. Americans have also been enthralled by the Presidential campaigns. Senator John McCain and Governor Sarah Palin, on the Republican ticket, both speak ardently about energy. The requested records touch upon all these topics that are dominating Americans' interest.

Once Judicial Watch obtains the requested records, it intends to analyze them and disseminate the results of its analysis, as well as the records themselves, as a special written report. Judicial Watch will also educate the public via radio programs, Judicial Watch's website, and/or newsletter, among other outlets. It also will make the records available to other members of the media or researchers upon request. Judicial Watch has a proven ability to disseminate information obtained through FOIA to the public, as demonstrated by its long-standing and continuing public outreach efforts, including radio and television programs, website, newsletter, periodic published reports, public appearances, and other educational undertakings.

The requested records will contribute significantly to public understanding. Not only is the public interested in the topics directly related to the request, but the records will clarify the public's questions about what can be expected in terms of energy policy if Senator McCain and Governor Palin win the election. The records will clarify the implications of conflict between Georgia and Russia for the United States. The records will clarify the current energy alternatives in place of dependence on the Middle East.

Given these compelling circumstances, Judicial Watch is entitled to a public interest fee waiver of both search costs and duplication costs. Nonetheless, in the event our request for a waiver of search and/or duplication costs is denied, Judicial Watch requests that it be contacted before any such costs are incurred, in order to prioritize search and duplication efforts.

We look forward to receiving the requested documents and a waiver of both search and duplication costs within twenty (20) business days. We take the statutory deadlines of the Freedom of Information Act very seriously – as does the Archivist of the


