## Secretary of Energy Advisory Board (SEAB) Members

**Scott Campbell** is the Senior Strategic Advisor of Baker Donelson, Washington, DC and President of the Howard Baker Forum, its public and international affairs affiliate.

Mr. Campbell also founded and directs the U.S.-Japan Roundtable on Nuclear Energy Cooperation, an ongoing program of the Howard Baker Forum that encourages and facilitates U.S. – Japan cooperation in nuclear energy.

Scott Campbell is a lawyer and former independent oil and gas company executive from Dallas, Texas who came to Washington in 1987 to serve in the Reagan Administration as Director of the Office of Policy, Planning and Analysis of the Department of Energy. He also served as the representative for the Energy Department on the National Security Council task force for the prosecution of the Gulf Tanker War.
