PROPOSED ACTION DESCRIPTION: Carib Energy (USA) LLC (Carib Energy) filed an application (Application) with the Office of Fossil Energy and Carbon Management (FECM) on September 14, 2021 (as clarified on October 26, 2021), seeking blanket authorization to engage in short-term exports of liquefied natural gas (LNG) previously imported into the United States from foreign sources. Carib Energy requests authorization to export (or “re-export”) this LNG in a volume equivalent to 0.48 billion cubic feet (Bcf) of natural gas on a cumulative basis for a two-year period, commencing on the earlier of the date of first export of LNG by Carib Energy or five years from the date on which DOE issues the requested authorization.

Carib Energy seeks to export this LNG in approved IMO7/TVAC-ASME LNG containers (ISO containers) loaded at the Crowley LNG Truck Loading Facility (Crowley Facility) located in Penuelas, Puerto Rico, and transported on ocean-going carriers or container vessels. As relevant here, Carib Energy seeks to export this LNG to any country in Central America, South America, or the Caribbean with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries). The application was submitted pursuant to section 3 of the Natural Gas Act¹ and 10 CFR Part 590 of the Department of Energy’s (DOE) regulations.

DOE’s proposed action is to authorize the exports described in the Application if DOE determines that such exports are not inconsistent with the public interest. If granted, the authorization would permit the requested LNG exports in ISO containers by vessel on a short-term basis from the Crowley Facility, subject to certain terms and conditions set forth in the DOE order.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; or (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

[✓] There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

[✓] The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
