Details

At approximately 0650 hours, I (b) (6) took a phone call in the Sergeants Office from (b) (6) employee (b) (6). (b) (6) stated, "At approximately 0635 hours I was driving on West Perimeter Drive and noticed a possible drone hovering 50-75 feet off the ground in the buffer zone. Due to the darkness I only saw the red and white lights." I notified the Central Alarm Station and (b) (6) responded to the area and did not see a drone. (b) (6) went to the new construction site on Mesquite Drive and asked if the construction crew had deployed a drone and they said, "No." I called (b) (6) employee (b) (6) who is an LLNL drone operator with (b) (6) and they confirmed they did not fly a drone. (b) (6) reviewed all cameras on the west side of the Laboratory on Milestone. He reviewed the cameras from 0625 hours to 0645 hours resulting with negative findings. (b) (6), and (b) (6) (left message) was notified of the incident.
