Significant Accomplishments:

Achieved over 4.5 million work hours without a lost time accident, and received the Million Work Hours Award from the National Safety Council.

Provided outstanding support to DOE by accomplishing work above-and-beyond the planned FY 2025 scope to advance the Paducah Site mission.

Provided outstanding support to DOE with the continued development of a holistic approach to environmental remediation at the Paducah Site.

Awarded approximately 64% of procurements worth over \$33 million to small businesses, exceeding goals established in the Small Business Subcontracting Plan.

Opportunities for Improvement:

As deactivation work transitions from nonfissile to fissile operations, FRNP should take initiative to strengthen Conduct of Operations by instilling professionalism into formal practices to ensure consistency in work outcomes.

Management continued initiatives to integrate with the Portsmouth Team and leverage lessons learned from similar projects and activities. FRNP should continue to leverage experience by adopting Nuclear Criticality Safety Evaluations successfully implemented at Portsmouth for deactivation activities.
