Formal Public Interaction

- **October 26: Idaho Cleanup Project Citizen's Advisory Board Meeting:** Sun Valley, Idaho
- **November 2: News Release:** Idaho Cleanup Project Core contractor Fluor Idaho issued a news release announcing that it had purchased more than \$78 million in goods and services from small businesses during the previous fiscal year.
- **November 4: Public Comment Period Closed:** The 60-day public comment period for the Class 2 Permit Modification Request (PMR) for the Volume 14 HWMA/RCRA Storage and Treatment Permit for the Liquid Waste Management System at the Idaho Nuclear Technology and Engineering Center closed. The PMR addressed the installation of a sump tank and clarifier tank in the Integrated Waste Treatment Unit.
- **January 25: Notice of Availability:** The Naval Reactors Facility ran an ad in the Idaho Falls Post Register announcing the availability of the five-year review report.
- **January 30: Idaho Cleanup Project Update:** Jack Zimmerman and Fred Hughes gave an update on the state of the Integrated Waste Treatment Unit to the representatives of the Idaho Department of Environmental Quality, Idaho Governor's Office and Idaho Attorney General's Office in Boise.
- **January 31: Idaho LINE Commission Meeting:** Jack Zimmerman presented an update on the status of the Idaho Cleanup Project to the State of Idaho's Leadership in Nuclear Energy Commission in Boise.
- **February 6: News Release:** DOE issued a news release announcing the Citizens Advisory Board's public meeting schedule for 2018.
