Significant Accomplishments:

MCS processed cylinders on track for meeting the annual targets with 388 processed at Portsmouth and 434 processed at Paducah through May 2025.

Current MCS project incident rates are 0.21 Total Recordable Cases (TRC) and 0.00 for Days Away, Restricted, or Transferred (DART) through May 2025, well below the project goals of 1.10 for TRC and 0.60 for DART rates.

MCS has been working hard to advance the long-term initiatives to improve the stability and efficiency of plant operations. MCS has retired the risk on the flow meters, with all production lines being updated. The installation of the last UF6 isolation valve at Portsmouth was completed May 31, 2025, retiring that risk as well. Planning continues for installation of EVH later this year. The final design and the DSA were completed on May 29, 2025.

The MCS DUF6 program completed the Windows 11 update, meeting the DOE Binding Operational Directive.

Opportunities for Improvement:

MCS had two contamination events occur during the reporting period which resulted in clothing contamination.

There were issues where the contractor did not maintain control of contractor equipment inadvertently allowing the two pieces of equipment to leave site without proper authorization as required by the offsite release program.
