ACTION: Request for information.

SUMMARY: The Department of Energy's Office of Nuclear Energy seeks information and feedback on the *Safely and Responsibly Expanding U.S. Nuclear Energy: Deployment Targets and a Framework for Action* and efforts associated with the deployment of advanced nuclear reactors and other nuclear facilities in the support of efforts to triple nuclear generation domestically by 2050. Information received through this RFI will inform future updates to this framework as appropriate.

DATES: Any interested persons and organizations are invited to submit comments on or before 11:59 p.m. ET on March 17, 2025.

SUPPLEMENTARY INFORMATION:

Urgently expanding nuclear energy deployment for both economic and national security benefits should be informed by intergovernmental and community engagement, Tribal consultation, and meaningful public participation. This RFI is part of the Federal Government's commitment to ensuring that all energy efforts are informed by the priorities and perspectives of the public.

Information Requested

Respondents may provide information on as many topics concerning the deployment of advanced nuclear reactors and requisite supply chain to support the tripling of nuclear generation domestically. Input is welcome from governments, stakeholders, members of the public, and private companies representing all backgrounds and perspectives.

DOE seeks public comment on achieving the deployment targets of tripling nuclear and seeks input on policies or resources to enable this goal across the following areas: (1) building new large reactors, (2) building small modular reactors, (3) building microreactors, (4) extending, expanding, and restarting existing reactors, (5) improving licensing and permitting, (6) developing the workforce, (7) developing component supply chains, (8) developing fuel cycle supply chains, and (9) managing spent nuclear fuel. These actions, many of which are already underway, apply to the U.S. government as well as to the U.S. nuclear industry.
