Re: Supplemental Information Supporting Request for Emergency Order Under Federal Power Act, Section 202(c), Encompassing Relief for Both Specified Resources and the Operation of Backup Generation Resources

Dear Secretary Wright:

Yesterday, PJM Interconnection, L.L.C. submitted an application for an emergency order under Federal Power Act, Section 202(c). PJM made that request because load forecasts, coupled with generator outages, show a threat to system reliability.

Through this letter, PJM submits additional factual information supporting its request. This morning, a critical generation facility that supports the affected Zones identified in PJM's September 16 application unexpectedly went offline. It is unclear whether it will return to service by today's evening peak, exacerbating the already tight system conditions and potential shortage of energy to supply the forecast load. This unexpected outage further supports the exigent need for the emergency 202(c) order PJM requested yesterday.

PJM appreciates the Department's expedited consideration of this request.
