WEATHERIZATION PROGRAM NOTICE 26-2
ISSUED DATE: July 9, 2026

SUBJECT: PROGRAM YEAR (PY) 2026 GRANTEE ALLOCATIONS

APPLICABLE TO: Annual Formula Grants

INTENDED AUDIENCE: Weatherization Grantee Program Managers, Weatherization Subgrantee Program Managers

PURPOSE: This document provides the funding amounts allocated to Grantees, which they will use to prepare and submit their applications to the U.S. Department of Energy (DOE) for the Weatherization Assistance Program (WAP) PY 2026.

SCOPE: These funding amounts apply to all Grantees seeking financial assistance support from DOE for WAP.

LEGAL AUTHORITY: The Energy Conservation and Production Act, Title IV, as amended, authorizes DOE to administer WAP consistent with the Code of Federal Regulations (C.F.R.) at 10 C.F.R. § 440¹ (WAP Regulations) and 2 C.F.R. § 200² (Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards).

PROCEDURES: On January 23, 2026, President Donald J. Trump signed H.R. 6938, known as the Commerce, Justice, Science; Energy and Water Development; and Interior and

Environment Appropriations Act, 2026. This act provides funding for Fiscal Year (FY) 2026 through September 30, 2026. Under this act, WAP received:

- \$329,000,000 for the Retrofit program,
- \$10,000,000 for Headquarters Training & Technical Assistance (T&TA), and
- \$30,000,000 for Weatherization Readiness Fund (WRF).

The total funding received for WAP is \$369,000,000.

DOE will not set aside funds from the FY 2026 appropriations to support the Sustainable Energy Resources for Consumers WAP sub-programs.

WAP determines annual allocations for each Grantee using a formula outlined in [10 C.F.R. § 440.10](https://www.ecfr.gov/current/title-10/section-440.10)³. This formula considers the Population Factor, Climatic Factor, and Residential Expenditure, and it is based on the annual budget appropriated by Congress and signed into Law by the President.

The final Grantee allocation amounts are detailed in Attachment one: Grantee Allocations. These allocations must be used in conjunction with Weatherization Program Notice (WPN) 26-1: Program Year 2026 Weatherization Grant Application.
