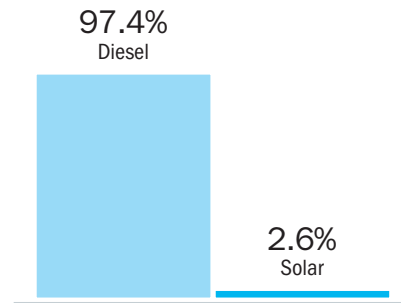

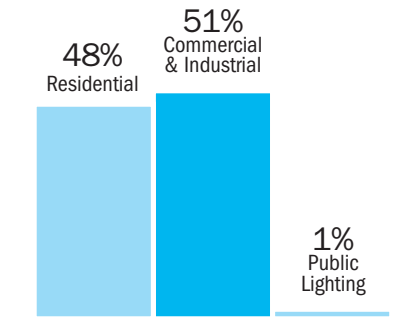

Electricity Consumption by Sector

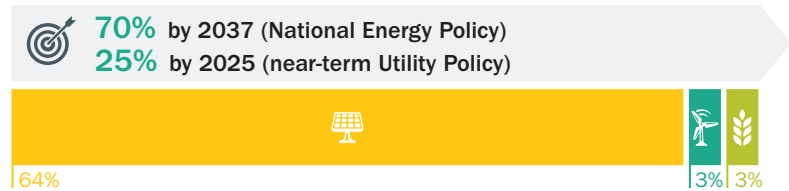
