Fiscal Year 2018 Deliverable Accomplishments

Enclosed is a summary of the completion of milestones by the U.S. Department of Energy (DOE) Environmental Management Los Alamos Field Office (EM-LA) for fiscal year (FY) 2018 required under the 2016 Compliance Order on Consent (Consent Order). Also enclosed is a summary of other deliverables submitted to the New Mexico Environment Department (NMED) for FY 2018.

Enclosure 1 lists FY 2018 milestones in Appendix B of the Consent Order, including their due, submittal, and approval dates. Most of the Appendix B milestones were submitted on or before their due dates. NMED granted two extensions to milestone due dates: one for field completion of well R-69 (FY 2018 milestone 13; granted a new milestone date of December 14, 2018) and one for the Phase 2 Pilot Amendment Testing Work Plan (FY 2018 milestone 10; granted a new milestone date of June 28, 2019). The extension for completion of R-69 was granted because of the unanticipated damage/breakage of the drilling equipment, which resulted in additional time necessary to complete drilling. The extension for submitting the Phase 2 Amendment Testing Work Plan was granted because the Phase 1 Pilot Amendment Test was not complete, and Phase 1 results are necessary to inform planning and implementation of the Phase 2 amendment test.

In addition to Appendix B Milestones, DOE EM-LA submitted several other deliverables required by NMED. Enclosure 2 contains a list of these deliverables and their submittal dates.
