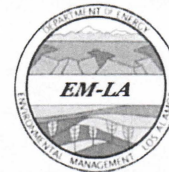

**Subject: Notice of Electronic Information Repository for the Los Alamos
 Legacy Cleanup Contract**


Dear Mr. Kieling:

Effective April 30, 2018, Newport News Nuclear BWXT – Los Alamos, LLC (N3B) was added as a co-operator of the Los Alamos National Laboratory Hazardous Waste Permit. The U.S. Department of Energy; Los Alamos National Security, LLC; and Triad National Security, LLC, are also co-operators (collectively, the Permittees). Pursuant to the requirements in section 1.10, Information Repository, of the Hazardous Waste Permit, the permittees are required to provide written notice to the New Mexico Environment Department Hazardous Waste Bureau of the establishment of an electronic information repository within 180 days of the effective date of the permit. Additionally, the permittees must post a public notice in local area newspapers.

The Los Alamos Legacy Cleanup Contract electronic information repository (electronic public reading room) is operational and available for public use at <https://www.energy.gov/em-la/information-center/los-alamos-legacy-cleanup-electronic-public-reading-room>. The public notice is slated to run in the following local area newspapers on October 24, 2018, and October 25, 2018: the *Santa Fe New Mexican*, the *Albuquerque Journal*, the *Rio Grande Sun*, the *Taos News*, and the *Los Alamos Monitor*. This electronic information repository contains regulatory information dating from May 1, 2018, to the present that pertains to the legacy waste cleanup at Los Alamos National Laboratory. The permittees' hardcopy public reading room is located at 94 Cities of Gold Road, Santa Fe, New Mexico, operating Monday through Friday, 8 a.m. to 5 p.m.
