Description:

- A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- B3.6 Siting, construction (or modification), operation, and decommissioning of facilities for indoor bench-scale research projects and conventional laboratory operations (for example, preparation of chemical standards and sample analysis); small-scale research and development projects; and small-scale pilot projects (generally less than two years) conducted to verify a concept before demonstration actions. Construction (or modification) will be within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible).

Rational for determination:

Colorado School of Mines (CSM) would develop a comprehensive and efficient reservoir simulator for modeling multiphase, multidimensional fluid and heat flow with the effect of rock deformation and chemical reactions in the Enhanced Geothermal Systems (EGS) geothermal reservoir. The lab work would take place at the CSM, Division of Engineering, Geotechnical Laboratories in Rooms 149 and 164 in Golden, Colorado. The project would be divided into seven tasks:

- Task 1.0 Development of a general framework model
- Task 2.0 Development of a rock mechanical module
- Task 3.0 Development and implementation of a chemical reaction module
- Task 4.0 Development and implementation of parallel simulation technologies
- Task 5.0 Development and implementation of general fracture conceptual models
- Task 6.0 Model verification and application studies
- Task 7.0 Project Management and Reporting

CSM claims no additional permits are needed and there would be no generation of air emissions associated with this work. Vented gas cabinets and fumehoods are used with scrubbers to prevent release of air pollutants. The university claim that all hazardous waste is disposed of according to university, local, state, and federals regulations. According to the university, a Chemical Hygiene Plan, waste disposal, and safety protocols are in place monitored by the each university Environmental Health and Safety office.

This proposal comprises conventional laboratory operations, data analysis, and actions to promote the research and development of more efficient geothermal technologies; therefore this project is categorized as CX A9 and B3.6.
