Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The Idaho Office of Energy Resources (OER) would perform scoping audits and subsequent energy efficiency upgrades in their K-12 existing school building under the State Energy Project (SEP) program American Recovery and Reinvestment Act (ARRA) funding. The primary purpose of this project is to reduce energy bills in K-12 school districts statewide, thereby avoiding the cost of purchased energy.

Once the scoping audits are complete the building retrofits would occur. The building retrofit activities within this project are be limited to: installation of insulation; installation of energy efficient lighting; HVAC upgrades; weather sealing; purchase and installation of ENERGY STAR appliances; replacement of windows and doors; and high efficiency shower/faucet upgrades.

The K-12 schools project would also focus on energy efficiency training and education for district operations and maintenance staff, as well as HVAC service providers, and professional engineers in Idaho.
