Description:

B3.6 Siting, construction (or modification), operation, and decommissioning of facilities for indoor bench-scale research projects and conventional laboratory operations (for example, preparation of chemical standards and sample analysis); small-scale research and development projects; and small-scale pilot projects (generally less than two years) conducted to verify a concept before demonstration actions. Construction (or modification) will be within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible).

Rational for determination:

DOE and cost share funding will be used by Abengoa Solar, Inc (Lakewood Colorado) to conduct an analysis a concentrator structure, the reflector that integrates into that structure, foundations, and installation techniques.

Phase 1 of this project has been previously reviewed by NEPA and has been issued a CX B3.6. This review is for Phase 2 of this project which involves continuing the analysis of solar thermal collector designs and prototyping promising designs. The prototyping and testing portion of the phase 2 work will involve module assembly, instrumentation, testing, data collection and data interpretation.

Individual prototype modules will be assembled and structurally tested at Abengoa Solar's Lakewood facility, Abengoa Solar's SolarTAC test facility in Aurora, and at NREL's solar outdoor test site.

Both of Abengoa's test sites include assembly/construction buildings and an adjacent, outdoor site for testing of parabolic trough solar collectors. Building and land permits from the City of Lakewood and the City of Aurora are current for both sites. The appropriate building and construction permits will be acquired by Abengao from the city of Aurora prior to the installation of the additional collector loops at the Solar TAC.

An R&D questionnaire has been filled out for both testing site. This document thoroughly addresses current site use, safety, and waste stream protocols.

This project comprises laboratory research and small-scale pilot project within or contiguous to an already developed area; therefore a CX B3.6 applies.
