Description:

The following Project Activity Sheets (PAS) are bounded by the signed SOW and are therefore categorically excluded under NEPA: #1 Improve City Facility, Multi-family, and Construction Waste Recycling, #2 Energy Efficiency Retrofits and Building Automation System Improvements for City Building, #5 Green Jobs Development Infrastructure, #6 Energy Outreach Coordinator and City Communications Program, #7 Residential Energy Audit, Implementation Support, and Retrofit Demonstration, #8 Financial Incentives Assistance and Revolving Load Fund, #9 Comprehensive Plan Sustainability Recommendation, #10 Technical Assistance (EECS), and #11 Administration of EECBG Programs.

Any projects submitted for EECBG funding that fall outside the bounds of the signed SOW will require a separate NEPA determination review.
