Description:

- A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

- B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The North Carolina Solar Center will use DOE ARRA funding to develop Solar Photovoltaic (PV) and Solar Hot Water (SHW) Train-the Trainer program which will leverage their network of partners and experience in the solar industry and serve as a train-the-trainer center for the Mid-Atlantic region.

Tasks include:

- Task 1.0 Establish a communications plan for working with partnering states, advisory board, and industry.
- Task 2.0 Identify LEI instructors from each state.
- Task 3.0 Establish Training Dates and Logistics for Tracks One and Two Courses.
- Task 4.0 Conduct Track One Training in Solar Photovoltaic and Track Two in Solar Heating and Cooling.
- Task 5.0 Develop real-time financial modeling tools (solar PV, solar heating and cooling) for partnering states.
- Task 6.0 Develop the online version tests.
- Task 7.0 Set up a project website
- Task 8.0 Design and construct the Solar PV and Solar Heating and Cooling mobile training trailer.
- Task 9.0 Work with industry partners to set up a tracking system and referral system
- Task 10.0 Establish official project board
- Task 11.0 Project Management and Reporting

Task 8.0 will involve investigating multiple designs for a mobile training trailer and a mock training roof. Construction and fabrication will then occur at the North Carolina Solar Center on the campus of North Carolina State University. The mock training roof is OSHA approved with 4/12 pitch on the ground and safety rails with steps to the mock roof. An R&D questionnaire has been filled out which discusses safety protocols established by the University for their laboratory training facilities.

Task 8.0 involves activities at demonstrate potential energy conservation and promote energy-efficiency; therefore a CX B5.1 applies.

Tasks 1.0 - 7.0 and 9.0 - 11.0 involve educational development, information gathering, outreach activities, and information dissemination; therefore a CX A9 and A11 apply.
