Description:

- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.
- B2.5** Safety and environmental improvements of a facility, including replacement and upgrade of facility components, that do not result in a significant change in the expected useful life, design capacity, or function of the facility and during which operations may be suspended and then resumed. Improvements may include, but are not limited to: Replacement/upgrade of control valves, in-core monitoring devices, facility air filtration systems, or substation transformers or capacitors; addition of structural bracing to meet earthquake standards and/or sustain high wind loading; and replacement of aboveground or belowground tanks and related piping if there is no evidence of leakage, based on testing that meets performance requirements in 40 CFR part 280, subpart D (40 CFR part 280.40). This includes activities taken under RCRA, subtitle I; 40 CFR part 265, subpart J; 40 CFR part 280, subparts B, C, and D; and other applicable state, Federal and local requirements for underground storage tanks. These actions do not include rebuilding or modifying substantial portions of a facility, such as replacing a reactor vessel.

Rational for determination:

Illinois Department of Commerce & Economic Opportunity will provide Fluorecycle, Inc. with \$440,667 in Recovery Act funds to expand its current fluorescent lamp processing and recycling operation with a second processing line. The second production line is to be installed at Fluorecycle's existing facility in Ingleside, Illinois. The equipment consists of a lamp recycling unit, a compact fluorescent lamp processor, conveyor, glass crusher, and trommel. The new production line will allow previously landfilled waste glass from current processing operations to be cleaned and pulverized to produce a locally marketable commodity.

The facility processes used fluorescent and high intensity discharge (HID) lamps and reclaims/recovers the mercury, glass, and metals in these wastes. The lamps are considered Universal Waste and may be hazardous waste due to the mercury. The facility currently has the required Resource Conservation and Recovery Act (RCRA) Part B permit. The new production line will not require a change in operation permits; the facility is fully permitted for its intended purpose.

This activity comprises actions to install equipment and machinery at an existing facility that will improve energy conservation by recycling fluorescent lamps and reducing landfill waste. Based on the information provided by the State and recipient, this activity is consistent with categorical exclusion B5.1 and B2.5.
