CX, EA, EIS APPENDIX AND NUMBER:

Description:

- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- A11** Technical advice and planning assistance to international, national, state, and local organizations.
- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The following activity is included in the City's signed Statement of Work (SOW) and is therefore categorically excluded under NEPA:

- Activity #3: Revolving Loan Fund

The following activity falls outside the bounds of the City's signed statement of work but is categorically excluded from further NEPA review:

- Activity #4: Program Administration. The City would fund an Energy Policy Analyst position to coordinate the City's existing energy efficiency initiatives including the Energy Smart Initiative, the Neighborhood Commercial Investment Program, and the State Department of Natural Resources' HERO program. All of these initiatives provide energy efficiency subsidies for home owners and businesses in the Greater New Orleans area. This activity is categorically excluded under NEPA under CX A9 (Information gathering, data analysis, document preparation, etc.) and CX A11 (Technical advice and planning assistance).

Any projects submitted for EECBG funding that fall outside the bounds of the City's signed SOW, other Activity #4 listed above, will require a separate NEPA determination review.


