These tasks involve activities where additional information will need to be procured and submitted to DOE NEPA in order to make a final determination. These tasks therefore are unallowable per this determination.

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

Prohibited actions include:

The applicant cannot purchase or lease land or water rights with neither DOE or cost-share funds, nor can the applicant use these funds to move forward with final design until further NEPA review is conducted.

Any construction, deployment, demolition, land/water acquisitions, procurement activities and/or equipment purchases, specifically for the construction/operation of the platform.

This restriction does not preclude you from:

Task 1.0 - 11.0 (all activities)

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.

Insert the following language in the award:

You are required to:

Submit an additional EF1 with specific information pertaining to the planned construction, deployment and operation of their proposed offshore research platform.

Note to Specialist:

This project involves tasks that are currently unallowable under NEPA and require submission of additional information (tasks 12.0 - 18.0). NEPA recommends this recipient's grant be placed on ASAP approval.
