Description:

Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. Rational for determination:

The Project Activity Sheet (PAS) titled Ohio State ARRA-EECBG - Activity 1 Mahoning County Building Retrofits submitted by the Ohio State Energy Office (SEO) includes the renovation, retrofit and upgrade of the existing heating, ventilation and air conditioning (HVAC) system in a County-owned building complex known as Oak Hill Renaissance Place as part of the Recipient's Award Activity 1 (Non-Entitlement Grants).

Oak Hill Renaissance Place, a former hospital complex, includes multiple buildings totaling 350,000 sq. ft. in County office space. The County determined that cost savings related to energy efficiency and energy demand reduction could be realized by converting the complex's HVAC system from the existing central steam heating plant system (with piping to individual buildings) to one or more gas-fired condensing boiler systems within each building. This conversion will allow for the removal of energy inefficient water-to-steam heat exchangers and the installation of energy efficient boilers in zoned areas. Although the renovated HVAC system will utilize most of the existing water distribution system piping, some re-piping (internal to the buildings) will be included. Minimal new piping (estimated at 95 feet in length) will be included external to the buildings, on County-owned property, to connect to the natural gas supply line. In addition to the new gas-fired condensing boilers, the installation of the following (internal to the buildings) will also be included: expansion tanks, air separators, piping (as described above), coil replacements, gas lines, and other similarly related materials and/or equipment.

This PAS is categorically excluded from further NEPA review under A9, A11, and B5.1.
