Description:

- **B3.6** Siting, construction (or modification), operation, and decommissioning of facilities for indoor bench-scale research projects and conventional laboratory operations (for example, preparation of chemical standards and sample analysis); small-scale research and development projects; and small-scale pilot projects (generally less than two years) conducted to verify a concept before demonstration actions. Construction (or modification) will be within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible).
- **B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The University of Albany, College of Nanoscale Science & Nanotechnology proposed to use federal funds to research and develop high efficiency, thin film silicon based solar cells in labs on the University of Albany campus.

This project includes enhancing Nano-crystalline thing film silicon solar cells through reactor design and construction, thin film characterization and feedback to reactor design, device theory and numerical simulation, and device deposition and performance evaluation. Also this project will improve thin film polycrystalline solar cells by silicon thing film deposition and aluminum induced crystallization, characterization of the thin film silicon, and prototype fabrication and testing. The final task involved in this project will be project management and reporting of findings.

Project activities will take place indoors within the confines of a laboratory setting on the University of Albany campus. An R & D questionnaire has been submitted with thoroughly addresses the universities safety and chemical handling protocols.

This project comprises information gathering and conventional research and development studies and small scale development of solar cells in existing laboratories; therefore a CX A9, B3.6, & 5.1 will apply.
