Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The State of Oregon will provide \$627,738 in Recovery Act funds to Estacada District High School to install biomass boilers at the Estacada High School and River Mill Elementary. Estacada High School is located at 355 NE 6th Ave., Estacada, OR 97023; River Mill Elementary is located at 850 N. Broadway St., Estacada, OR 97023

A 2.91 MBTU/hr biomass boiler (Solagen model HDF-WC-563) will be installed at Estacada High School and a 1.08 MBtu/hr boiler (Solagen model HDF-WC-277) will be installed at River Mill Elementary. The boilers are stoker fed and have a flue vent stack with cyclone separator and fan for particulate removal. The plan is to install the boilers immediately outside of the current boiler room on concrete pads. Wood storage bins will be constructed adjacent to the boiler. The area will be secured and weatherized. For both boiler installations, the total area affected is approximately 20ft x 70ft. The affected area is currently manicured lawn and pavement.

The project involves the installation of two boilers that are within the 3 MBtu/hr size guideline of the SEP template. The biomass boilers are replacement systems for the oil-fired boilers currently in use. The current oil-fired boiler systems will be maintained as back-up systems in the event of need. The installation will occur on previously disturbed land.

In view of the information provided by the State and applicant, DOE has determined that the work outlined is consistent with activities identified in the SEP Template and Categorical Exclusion B5.1.
