Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

## CX, EA, EIS APPENDIX AND NUMBER:

Description:

- B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

## Rational for determination:

The State of Oklahoma will provide \$547,562 in Recovery Act funds to Shattuck Hospital Authority to replace two (2) 45 year old boilers with more energy efficient boilers, replace the emergency back-up boiler, and upgrade the HVAC system. The work will be performed at the Newman Memorial Hospital located at 905 S. Main, Shattuck, OK, 73858.

Recovery Act funds will be used to purchase and install an 80HP, 2680 lb/hr high-pressure, American Standard, Kewanee Scotch Generator and a 2464 lb/hr low-pressure American Standard, Kewanee Type C boiler. These will replace the two 45 year old boilers in the hospital. Funding will also be used to install four (4) 50-ton modular chillers. These will replace the current chillers at the hospital and upgrade the Hospital's current HVAC operations. The emergency generator will be installed on a concrete pad outside of the physical structure of the Hospital and properly enclosed to ensure safe operations. The new generator will replace the Hospital's existing generator.

Memorial Hospital has provided service to the community for over 100 years. The current building was constructed in 1964 after a fire destroyed the original building. The Hospital is in consultation with the State Historical Preservation Office concerning the proposed work.

In view of the information provided by the State and recipient, DOE has determined that the work outlined is consistent with activities identified in Categorical Exclusion B5.1, B2.1, and B1.4.
